This internship would be ideal for graduate students interested in water policy, infrastructure, sustainability, community development, public health, and social and economic equity. This is an opportunity to gain a deeper understanding of the interconnections between water systems, the environment, and racial and economic equity in the US, and to contribute to shaping more equitable and sustainable policies and outcomes.

Project Descriptions

National Water Equity Taskforce

The US Water Alliance is undertaking a two-year project to better understand, catalogue, and accelerate the adoption of promising programs and policies that improve outcomes for vulnerable communities through inclusive and integrated water management. The Water Equity Taskforce will work with water and wastewater utilities in 6-8 cities to accelerate the adoption equitable water management policies and programs. The Taskforce is dedicated to building the organizational, policy, and partnership capacity of utilities, community organizations, and other stakeholder to bend the course of our nation's water future to be more equitable. Participating cities will develop policies and initiatives focused on issues like water affordability, safe and accessible water, flooding, and climate resilience.

Responsibilities

- Research water management and equity issues in participating cities, as well as model policies and programs
- Assist with the development of water equity profiles for each city, following the structure of US Water Alliance report An Equitable Water Future
- o Assist with planning learning exchanges, workshops, and trainings for participating cities

One Water Policy Initiatives

The US Water Alliance convenes the **One Water Hub**—a collaborative mechanism for water leaders who are driving a paradigm shift towards more sustainable, integrated, and inclusive approaches to water management. It is a platform for diverse, cross-sector leadership to accelerate their work on One Water through peer exchange, knowledge building, partnership development, and the co-creation of model programs and policies. The One Water Hub is the anchor of the Alliance network—it brings together diverse stakeholders who do not typically interact with one another, but can benefit from collaboration on common-ground solutions. With our members, we frequently undertake policy and program initiatives to accelerate the adoption of integrated water management.
